## 2010 District Populations

The County of Imperial was last redistricted in 2011 with a process led by the Board of Supervisors. The populations of each district at that time were based on the 2010 Decennial Census.<sup>1</sup>

As the following table shows, utilizing the American Community Survey (ACS) data from the 2006-2010 vintage which would be used in the 2011 redistricting, all five districts were above 50% of the Latino Citizen Voting Age Population (CVAP).

## Population Growth and Deviations

The US Census has released in a “Legacy Format” the data from the decennial census, identifying the whole count of persons and where they resided as of April 1, 2020. Redistricting Partners has concluded the work of placing this data into the census blocks, block groups, and tracts.

This data represents the whole population data prior to a state required reallocation of prison population that will be conducted by the Statewide Database at UC Berkeley. This adjusted data will be completed in the coming weeks and updated counts will be provided at that time.

Based on this data, the county has increased in population by 5,174 counted residents, or 3%, since the last decennial census. This is below the state’s population change of 6.1%. District 3 saw the largest increase of population with 3,362 additional counted residents and a growth rate

<sup>1</sup> These counts are based on the 2010 data put into the 2020 Census geography. There may be slight differences as many census blocks were consolidated and this would cause counts to shift since the 2011 redistricting.

of 8.6%. District 4, other the other hand, had the slowest growth rate with 0.8%. All five districts saw an increase in population.

With a countywide population of 179,702, the ideal population for any district in the currently available complete census dataset prior to the reallocation of prison population would be 35,940. The seat with the largest population is District 3 at 42,416 (+18%) and the smallest is District 2 at 30,340 (-15.6%), placing the county at a total of 33.6% deviation, well above the 10% required deviation range.

The ACS which contains the ethnic and racial subgroups utilized for Voting Rights Act calculations have been finalized for the current redistricting cycle. This data shows changes in the ethnic composition of districts since the prior redistricting. Overall, Adult Citizen growth was 32.3% among Latinos and .6% of Asians, while the Black population saw a negative growth rate of 24.1%. The total CVAP for the county grew at a rate of 16.6%

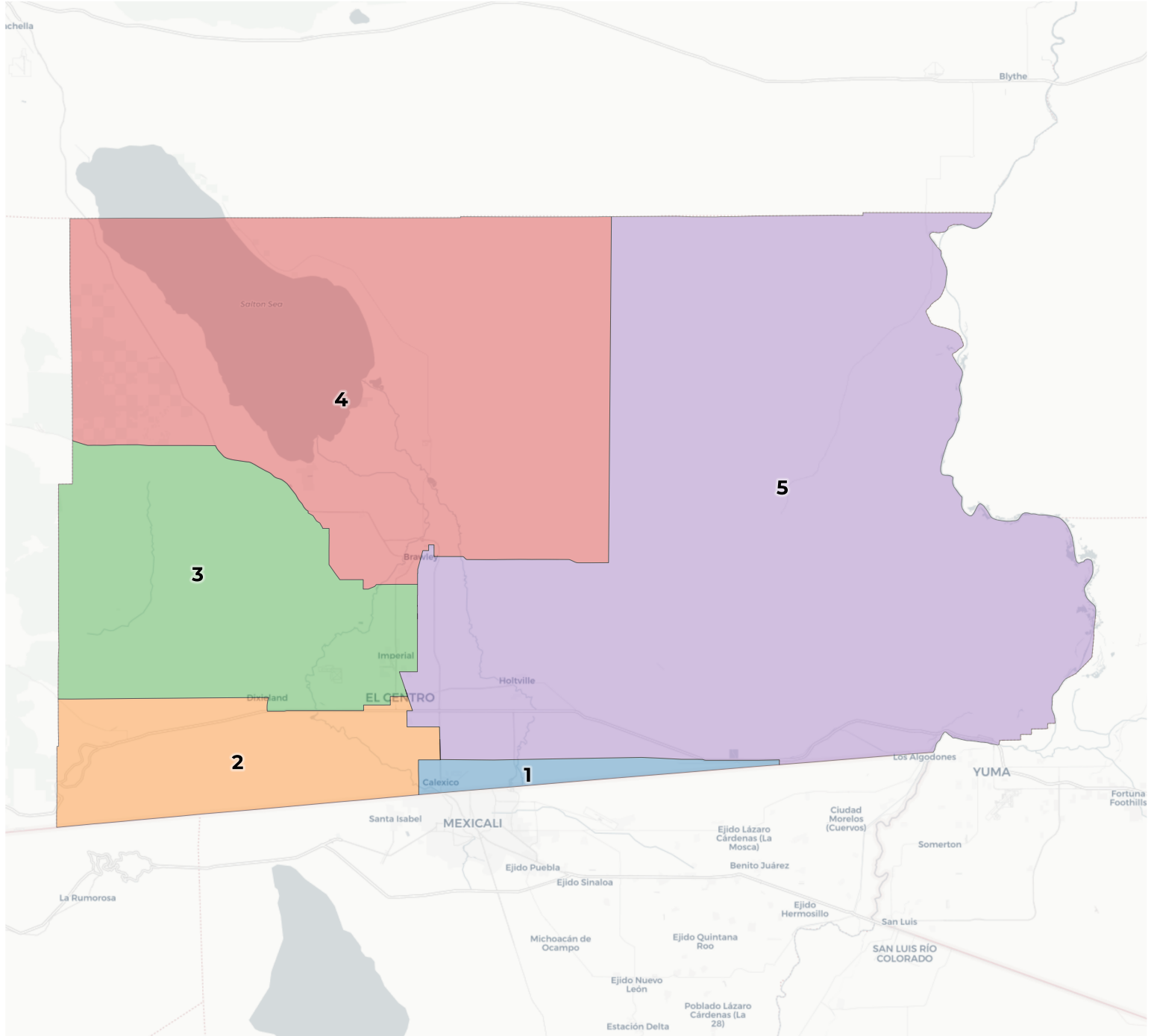
total population count of the 2020 Census. This data is expected to be finalized with a State Prison Population reallocation by September 23<sup>rd</sup>.
