The Redistricting Process

The Fair Maps Act

Imperial County is required to hold at least four hearings under the Fair Maps Act (FMA).

- One to two pre-map hearings to collect community of interest testimony
- Two map hearings to discuss proposed maps, the second hearing can be the final if no changes are made to the maps presented
- An optional final hearing to pass the final map



Traditional Redistricting Principles

Preventing a Districting from becoming a Gerrymander


There are a number of criteria that have been used nationally and upheld by courts.

- Relatively equal size people, not citizens
- Contiguous districts should not hop/jump
- Maintain "communities of interest"
- Follow city and census designated place boundaries
- Keep districts compact appearance/function


